Each passing dog will receive a green rosette offered by WCNI

Dogs must be on lead at all times during test hours. Please clean up after your dogs

Entry Fee: TD \$75.00 TDX \$120.00
(includes \$.50 AKC Recording Fee and \$3.00 AKC Event Services Fee)

Entries will be taken in order of receipt and a drawing held by the Test Secretary, Wednesday, September 17, 2020 at 7:00 pm at the test secretary’s home 28913 S. Gouger Rd, Manhattan, IL 60442 to determine which entries will participate in the test. The public is invited.

The Tracking Dog Test will be limited to 3 Weimaraners. If the limit is not reached in Weimaraners, other breeds may enter using the following procedure: Draw (1) Weimaraners without a TD or TDX title, Draw (2) Weimaraners with a TD or TDX title, Draw (3) Other breeds without a TD or TDX title, Draw (4) Other breeds with a TD or TDX title. If the limit for entries is not reached in one test and the limit is exceeded in the other test, the number of tracks will be exchanged up to the limit set by the AKC Tracking Regulations.

There are no actual scores for the TD/TDX Test, but dogs will be rated “Passed” or “Failed” and TD or TDX certificates will be issued by AKC confirming all dogs rated “Passed.”

Entries will not be accepted without proper fees and signatures and must be on approved entry forms with the agreement printed on the reverse side. Telephone, facsimile, email and unsigned entries cannot be accepted. Entries sent by overnight delivery MUST include signature release. CERTIFICATION FORMS MUST BE SENT WITH ENTRY FORMS FOR DOGS THAT HAVE NOT PASSED AN AKC TRACKING DOG TEST.

No entry fee will be refunded except that of an alternate who does not participate and whose entry fee will be refunded within seven days following the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry.

In the event an accepted entry cancels after the closing of entries, the Test Secretary shall contact the alternates according to their placement on the alternate list. Upon such notification, alternates shall have the option of participating in the test.

In the event an accepted entry is absent the day of the test, it shall be the responsibility of the Test Secretary to determine if alternates are present and to determine by their position on the alternate list which alternates shall participate.

Drawing by lot for the assignment of dogs to the tracks is the responsibility of the Judges.
