A standard AKC Rosette to all placed dogs in all stakes.

All stakes to be run on a single course without a bird field. Native and liberated quail or other game birds will be used. Blank pistols will be fired on pointed birds including all puppy stakes. Only a blank pistol incapable of firing live ammunition may be used by handlers.

ALL STAKES, OPEN AND AMATEUR ARE WALKING STAKES.

Horseback scouting is allowed in all stakes, but no horses will be provided. Stakes with less than (4) entries will be cancelled and entry fees returned. Bitches in season shall not be eligible for entry and shall not be allowed on the grounds. The use of AKC approved tracking collars will be permitted in accordance with the American Kennel Club rules.

All handlers, judges and gallery must be attired in a article of blaze orange during any retrieving stakes call backs. Where live fire is present. A blaze orange hat and vest are need. Must equal 400 sq in.
